7.2.1 Mr Ron Baines - University of Tasmania Move to Inveresk

1. Is Council considering the University of Tasmania's (UTAS) proposal to utilise the Albert Hall for up to 600 students and will UTAS reimburse the Council?

The Mayor, Alderman A M van Zetten, responded by saying that the proposal was part of the current UTAS Master Plan which has been circulated for public comment and input and if a request is forwarded to Council it would be considered. Reimbursement would occur if the proposal was accepted.

2. Is the faux railway station at Number 2 Invermay Road, Invermay to be demolished to make way for the area's use by UTAS?

The Mayor, Alderman A M van Zetten, responded by saying that he was unaware of any such plans.

Mr Michael Tidey (Acting General Manager) added that the Community Consultation Plan circulated by UTAS does include different uses for the property, however, no formal application has been received at this stage.
