4.1 Deputation - Tourism Northern Tasmania

DECISION STATEMENT:

To receive a deputation at 10.00am from Mr Chris Griffin (Chief Executive Officer - Tourism Northern Tasmania) initiated by Ms Tracey Mallett (Manager Community, Tourism and Events).

RECOMMENDATION:

That the Strategic Planning and Policy Committee receives a deputation from Tourism Northern Tasmania regarding the presentation of Tourism Northern Tasmania's Annual Report 2016/2017.

Mr Chris Griffin (Chief Executive Officer - Tourism Northern Tasmania) presented the 2016-2017 Annual Report to the Committee but noted the main purpose of the presentation was to highlight the strategic process review along with future directions and driving aspirations for the upcoming year.

The strategic review process commenced in August 2017 and is expected to be finalised in March 2018 when it will be provided to stakeholders. There has been extensive consultation to date with the discussions revealing six prime questions requiring direction and answers. The areas of direct concern as a result of discussions with stakeholders are related to brand of place, highlighting Launceston as a great regional city of the world, embracing the disruption, centring on the community as the host, audience centric marketing, the attraction and dispersal of technology and the use and exploration of real-time data. Mr Griffin also noted that the top priorities for the 2017-2018 year are concerned with the destination action plan, Cataract Gorge, a visitor engagement strategy and utilising events as visitor magnets.

Following the presentation Aldermen made reference to how tourism operators should work together to gain joint leverage from tourism and tourism operations, negating the boom and bust cycle, how tourists gain access to the State (ships, airlines, etc.), visitor satisfaction, tourist participation and the input and strategy of local traders and tourism operators.

4.2 Facilities By-Law

DECISION STATEMENT:

To consider the proposed Facilities and Local Highways By-Law and Regulatory Impact Statement prior to Council giving notice of its intention to make a By-Law.

RECOMMENDATION:

That the Committee considers the draft Facilities By-Law and Regulatory Impact Statement before they are submitted to a Council Meeting for the purpose of recording an intention to make a By-Law under section 156 of the *Local Government Act 1993*.

Mr Michael Jacques (Senior Legal Advisor) fielded questions and comments from Aldermen regarding the presentation of the facilities By-Law. It was noted that generally By-Laws expire and require review on a ten year cycle. Comment was made regarding the By-Law content with regard to unsightly buildings, abandoned vehicles, etc. and Mr Jacques noted that with the review of the current By-Law it is now proposed the By-Law be strengthened in order to improve the power and role of the regulatory officer when enforcing local conditions.
