DECISION STATEMENT:

The following question was asked by Mr Basil Fitch at the Council Meeting of 10 September 2018 and has been answered by Mr Michael Jacques (Senior Corporate Legal Advisor).

QUESTION and RESPONSE:

1. Is there a written agreement that UTAS will transfer the National Automobile Museum of Tasmania back to Council?

Response:

The National Automobile Museum of Tasmania (NAMT) relocation project is an arrangement between the University of Tasmania (UTAS) and the NAMT. The agreement is that when the new building is completed, the building and the land are to be transferred to the Council as part of a broader exchange of land for the inner city campus redevelopment. No contract is yet signed in relation to that arrangement between UTAS and the Council, but Council will be obtaining an executed agreement prior to making those transfers.

The following question was asked by Mr Paul Spencer at the Council Meeting of 10 September 2018 and has been answered by Mr Bruce MacIsaac (Director Facilities Management).

QUESTION and RESPONSE:

1. Why did Council sell Killafaddy Saleyards for approximately \$140,000 five or six years ago for less than valuation? Killafaddy Saleyards recently re-sold for much more than valuation.

Response:

In early 2014, Council resolved to sell the Killafaddy Saleyards after a publicly advertised expression of interest process. The offers were assessed and the one which represented best value for money was accepted.

This decision to sell the Killafaddy Saleyards was made for operational reasons as the yards were the only saleyards of the State's nine markets to be run by a council. On this basis, it was determined by Council, that the operation of a saleyard was not a core service which it wished to provide to the community.

As the saleyards no longer belonged to Council any subsequent decision to sell was not a matter for Council's consideration.

DECISION STATEMENT:

To consider and determine a development application pursuant to the Land Use Planning and Approvals Act 1993.

RECOMMENDATION:

In accordance with sections 51 and 57 of the *Land Use Planning and Approvals Act 1993* and the Launceston Interim Planning Scheme 2015, a permit be granted, for DA0449/2018 - Business and Professional Services - Change of use to an office at 14/61 George Street, Launceston subject to the following conditions:

1. ENDORSED PLANS & DOCUMENTS

The use must be carried out in accordance with the endorsed plans and documents to the satisfaction of the Council unless modified by a condition of the Permit:

- (a) Covering Letter, Prepared by AK Consultants, Dated 7/8/2018.
- (b) Site Plan, Prepared by AK Consultants, Dated 6/8/2018.
- (c) Floor Plan, Prepared by AK Consultants, No Date.

2. NO DEVELOPMENT APPROVED

This permit does not approve any development on site, including signage

3. USE LIMITATION

This permit allows the use of the site for *an office,* defined as *Business and Professional Services* in the Launceston Interim Planning Scheme 2015. Hours of operation must be limited to between 8.00am and 6.00pm - Monday to Friday.

4. LEGAL TITLE

All development and use associated with the proposal must be confined to the legal title of the subject land.

5. AMENITY - COMMERCIAL/INDUSTRIAL USE

The on-going use on this site must not adversely affect the amenity of the neighbouring properties and the general locality by reason of the processes carried on; the transportation of materials, goods or commodities to or from the subject land; the works or materials; the emission of noise, artificial light, vibration, odour, smoke, dust, waste water, waste products, oil or any other source of nuisance.

Notes

A. <u>General</u>

This permit was issued based on the proposal documents submitted for DA0449/2018. You should contact Council with any other use or developments, as they may require the separate approval of Council. Council's planning staff can be contacted on 6323 3000.

This permit takes effect after:

- a. The 14 day appeal period expires; or
- b. Any appeal to the Resource Management and Planning Appeal Tribunal is withdrawn or determined; or
- c. Any agreement that is required by this permit pursuant to Part V of the Land Use Planning and Approvals Act 1993 is executed; or
- d. Any other required approvals under this or any other Act are granted.

This permit is valid for two years only from the date of approval and will thereafter lapse if the development is not substantially commenced. An extension may be granted subject to the provisions of the Land Use Planning and Approvals Act 1993 as amended, by a request to Council.

B. Restrictive Covenants

The granting of this permit takes no account of any covenants applicable to the land. The permit holder and any other interested party, should make their own enquires as to whether the proposed development is affected, restricted or prohibited by any such covenant.

If the proposal is non-compliant with any restrictive covenants, those restrictive covenants should be removed from the title prior to construction commencing or the owner will carry the liability of potential legal action in the future.

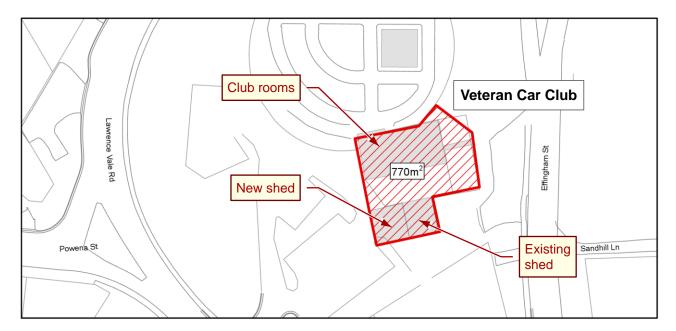

 - any infrastructure or any infrastructure installed by the tenant or Council in relation to the tenants occupation;
 - building in good and reasonable order; and
 - public liability insurance of at least \$10 million.
