General Terms

1. Starts at 3pm on January 20, 2017
2. All entries due Thursday 18 January, 2017
3. Payments are to be made at the time of entry. No entries will be accepted without payment
4. Prize money will be award on the day via Cheque
5. Participants numbers will be limited to 250 entrants
6. Acceptable payment methods include: Cash, EFTPOS or Cheque at the Launceston Leisure & Aquatic Centre Customer Liaison Desk
7. The Leisure & Aquatic Centre 50m leader board will display the winning male and female competitors name and time
8. All heats will be seeded on entry times
9. Swimmers who do not submit times shall be considered the slowest and shall be placed at the end of the list

Rulings

1. All decisions will be made final by the Referee designated by Launceston Leisure & Aquatic Centre
2. The Referee may intervene in the competition at any stage to ensure that the FINA, IPC and Swimming Australia regulations are observed, and shall adjudicate all protests related to the competition in progress

Freestyle Rules

1. Freestyle means that in an event so designated the swimmer may swim any style, except that in individual medley or medley relay events, freestyle means any style other than backstroke, breaststroke or butterfly
2. Some part of the swimmer must touch the wall upon completion of each length and at the finish
3. Some part of the swimmer must break the surface of the water throughout the race, except it shall be permissible for the swimmer to be completely submerged during the turn and for a distance of not more than 15 metres after the start and each turn. By that point, the head must have broken the surface

Anti-Doping

1. All competitors agree to adhere to all ASADA Rules and regulations
