## <u>Road Owners consent for lodging application incorporating works within the road</u> <u>reserve: Westbury Road and Rose Lane SOUTH LAUNCESTON</u>

This letter, issued pursuant to Section 52(1B)(b) of the Land Use Planning and Approvals Act 1993 is to confirm that the applicant has consent to lodge a development application with the Launceston City Council (the Council) that involves Council managed land, being Westbury Road and Rose Lane.

The proposal is to:

- Provide an urban BAR treatment for the facilitation of right turn manoeuvre from Westbury Road (southbound) into Rose Lane (westbound) including:
  - The realignment of kerb on the eastern side of Westbury Road,
  - Relocation of the street light located in the southern kerb outstand
  - The installation of no standing restrictions in front of No. 13 Westbury Road,
  - All necessary works to facilitate the above requirements including to third party services where consent to alter these has been secured from the responsible authority.
- Widening of Rose Lane in accordance with the recommendations of the GHD 9 Rose Lane Impact Assessment for Old Launceston Seaport P/L dated 21 October 2022 submitted as part of the application and the construction of two accesses and footpath.

The signing of this letter is not, in any way, an approval of the application or any works associated with the application, which must yet be determined under the provisions of the Tasmanian Planning Scheme - Launceston.

The delegation to act on behalf of the general manager has been delegated in Instrument of Delegation signed the 15 October 2020.




