Guest Presentation

Liz Bowerman presented the opportunity to reconvene a version of the Homelessness Response Group given the need for more frequent connection of stakeholders between HAC meetings, and the need for a more agile and cohesive response to day-to-day issues as they arise.

Lara Alexander and Liz Bowerman have identified and contacted members of the previous Homelessness Response Group which have been well received. City of Launceston is supportive of establishing this group and will provide a representative on the group. The proposed model would see meetings held monthly initially while the group is developing, then bi-monthly in between HAC meetings. It is the intention that this group would feed in to the HAC meetings to provide relevant updates, advice and recommendations as required. It was noted that the naming of this group should ensure that it differentiates itself from the previous Homelessness Response Group.

Liz Bowerman and Nindarra Wheatley will coordinate the group to formalise the reestablishment. This was supported by the HAC.

Service Updates

Head to Health is now in Canning Street with extended opening hours, open until 9pm weekdays. Open on weekends from 10-2pm.

Vinnies reported seeing more clients with rent stress. This was consistent with other service providers represented on the committee. Higher cost of living issues also rising among clients by service providers.

YMCA shower services are being reviewed. This is a work in progress and more information will be circulated to committee when new service is up and running.

7. GENERAL BUSINESS

City of Launceston will continue to liaise with relevant stakeholders to develop or join a database for information sharing across service providers that remains confidential for those sleeping rough in our community.

Homelessness Response Group to be re-established that will go under a different name to avoid confusion. Liz Bowerman and Nindarra Wheatley to initiate inaugural meeting. These meetings will be held in the month in between the HAC meetings.

City of Launceston Homelessness Protocol to be included in the Homelessness Action Plan.

Dan Ryan to contact Strike It Out to advise that there is currently not a vacant position on the HAC. It was agree that this organisation would offer great value to the response group once established and that an invitation to participate would be extended.

City of Launceston to Update Reach Out contact foldout card. Nindarra Wheatley will liaise with service providers to obtain up to date information for an updated version to be created. Suggestion from the committee that a virtual version could be created to be easily updated rather than a reprint of the paper based version each time.

No Fridge recipe book was tabled by Councillor Razay as this could be useful for homeless that do not have access to fridge. Nindarra Wheatley to liaise with service providers and provide an update at next meeting.

Suggestion tabled of an incentive campaign for Air B&B to offer short term rental over winter period. City of Launceston will investigate possibilities.
