# **Purpose - Homelessness Advisory Committee**

Homelessness is a complex issue and there are many factors that contribute to a person's homelessness. Many of these factors lie outside the remit of local government, however through an educated, collaborative and needs focused approach, the City of Launceston is committed to working with community to play a constructive role in the provision of strategies and actions to support the homeless community.

The primary purpose of the Homelessness Advisory Committee is to:

- Enable a collaborative approach between key sector service providers, community members and relevant levels of government in addressing the short, medium and long-term needs of Launceston's homeless community.
- Identify, support and coordinate achievable actions which will assist in addressing the evolving needs of Launceston's homeless community.
- Develop a greater and shared understanding of the roles, responsibilities and priorities within the community in responding to homelessness.

# Stephen Hill

Over allocation currently, Brad responding to calls around the community. Orana House at 90% constantly. Stay in contact with Housing Connect, needing pathways for larger families with multiple children is becoming a challenge. Emergency relief still ongoing. Oz Harvest is a local partner

#### Nic Green

Catholic Care having larger families accessing support for housing also - Unable to find these families emergency accommodation when needed. Currently have x2 underage kids that need to be housed but together struggles with this at the moment. CR Walker asked Nic if CC have a budget allocated case to case which can be dependent on situation.

## **Dareen McGhee**

Housing Connect worker, spoke about his previous work for Queensland and Logan Zero a project on homelessness across several states in Australia. Worked closely with services and outreach groups that were setup specifically for homelessness and then fed back into their local action group. Darren showed the committee members the online dashboard for Logan Zero and how it works and what stats can be shown ect.

Nic asked if we have a membership for Alliance to end homelessness. Apparently, some members do yes.

## **CR Lambert NMC**

Token system developing for showers for homelessness. Would be in conjunction with helping hands and Council Officers, location at Memorial Hall at Longford and adjoining Communities happy to be apart. Discussion around mobile and travelling around. NHH property purchase, currently lobbying in regard to price ect.
